A BFS VISA Prepaid Card can be used worldwide for purchases and payments and to obtain cash from an ATM wherever they are accepted.

FEATURES AND BENEFITS AT A GLANCE

- **More control and easier to budget.** You manage your own money by limiting the amount you load onto your card. Each time you use your card the purchase amount is automatically deducted from your card balance.
For example, it is a great way to give teenagers access to funds as needed, paying pocket money, spending within their allowance, and obtaining a record of expenditure,
- **Wide usage.** Allows you to shop online, make purchases over the phone or by mail, pay for goods and services in stores where VISA Prepaid Cards are accepted,
- **Accessibility.** Gives you 24-hour online access to check your prepaid card balance and transaction history, with the ability to change your PIN or block your card anytime,
- **Convenience.** It is a faster way to pay for your small purchases (under \$100) by using Visa payWave's contactless technology, where available,
